MYASTHENIA GRAVIS (MG)/LAMBERT-EATON SYNDROME (LES) EVALUATION #83369

EXPLANATION: Acetylcholine Receptor (AChR) Blocking Antibody testing will become obsolete on July 9, 2009. Currently, the AChR Blocking Ab test is only performed through reflex as part of this evaluation when AChR Modulating antibodies is 40% to 100% loss or indeterminate. AChR blocking antibodies represent a minority of the AChR antibodies and usually occur in association with AChR binding antibodies and are very rarely present without elevated AChR modulating antibodies. The AChR Modulating antibodies test, as routinely performed in our laboratory, detects both AChR Modulating antibodies and AChR Blocking antibodies. The separate measurement of AChR Blocking antibodies offers no information that additionally informs the diagnosis and management of myasthenia gravis (MG). Therefore, Mayo Medical Laboratories will cease performing selective testing for AChR Blocking antibodies in an effort to provide more cost-effective MG testing.
