Reason For Referral

MCR

Family history of mucopolysaccharidosis type IIIB (Sanfilippo syndrome type B). Test for the presence of familial alterations in the NAGLU gene.

Result

The c.764+1G>A and c.1022-1G>C alterations were NOT detected.

Interpretation

MCR

Absence of the mutation(s) previously identified in an affected family member indicates that this individual is at no greater risk than someone in the general population to be a carrier of mucopolysaccharidosis type IIIB (MPS-IIIB), also known as Sanfilippo syndrome type B.

This assay does not rule out the presence of other disease causing mutations in this gene or other genes associated with metabolic disease. Errors in the diagnosis or pedigree provided to us, including non paternity, may lead to an erroneous interpretation of the test results.

A genetic consultation may be of benefit.

Unless reported or predicted to cause disease, alterations found deep in the intron or alterations that do not result in an amino acid substitution are not reported. These and common polymorphisms identified for this patient are available upon request.

CAUTIONS:

Test results should be interpreted in context of clinical findings, family history, and other laboratory data. Misinterpretation of results may occur if the information provided is inaccurate or incomplete.
